By a general indorsed writ of summons dated 23 June 2015 and statement of claim dated 18 August 2015 issued by Sunway International Holdings Limited (the “**Issuer**”) and its wholly-owned subsidiary (collectively, the “**Plaintiffs**”) against certain parties (collectively, the “**Defendants**”) to a sale and purchase agreement dated 3 October 2013 (the “**Agreement**”), the Plaintiffs claim that the Defendants have fundamentally breached the terms and conditions of, and hence rescinded the Agreement. Therefore, as far as the Issuer is concerned, the remaining Convertible Notes issued under the Agreement have become void and are not capable of converting into shares of the Issuer.
