There were no Shares entitling the holders to attend and abstain from voting in favour of the Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules and no Shareholders or their associates were required under the Listing Rules and the Bye-laws to abstain from voting on the Resolutions at the AGM.
